REGISTRATION:

- A non-refundable registration fee of R1 500.00 is payable **once the acceptance letter is issued.**

METHOD OF PAYMENT:

We have become a "cashless" school, all payments to be made by EFT or at the bank, or cash payment at an ATM. You can also arrange a stop order at your bank.

NB! NO CASH OR CARD PAYMENTS CAN BE MADE AT THE OFFICE.

DISCOUNTS:

A 5% discount applies when the full yearly amount is paid before 31/01/2026 (Only applicable to the yearly fee, excluding the registration fee)

Family discount of R300 per learner per month, applies only for 3 or more learners.

PAYMENT SCHEDULE:

REC is a Private School, fees are payable strictly **MONTHLY**, from January to November. Payments are to be made **BEFORE** the last day of each month. Because we already allow fees to be paid in arrears on or before the last day of each month.

REC is registered with Transunion ITC, and all account payment profiles, patterns and behavior is recorded monthly with the Credit Bureau.

ARREARS:

If payment of fees is not received on or before the last day of the month, a notice will be sent home with the learner and emailed to the parents and if payment is not received within 7 days of the letter, the learner will be deregistered from REC, and a transfer letter will be issued. The learner will not be allowed back in class until the fees are paid in full.

TRANSFERRING TO ANOTHER SCHOOL:

One month's notice must be given when a learner transfers to another school. If no notice is given, a cancellation fee of R1500 will be applicable.

DISCIPLINARY PROBLEMS:

If a learner is expelled out of the School or Hostel due to disciplinary problems, the Account Payer will still be responsible for the School and/or Hostel fees for that month, no credit will be given.
